

Minutes of the Williamson County Historical Commission

A regular meeting of the Williamson County Historical Commission was held on Thursday, January 14, 2010, at 4:00 P.M., in the District Courtroom of the Williamson County Courthouse at 710 Main Street in Georgetown, TX. doing this? 3. How should we reimburse for expenses incurred by the Williamson Museum when they help with notices? 4. Voelter read from a list of other memberships we have purchased. There was some lengthy discussion. Nelma Wilkinson motioned to table the membership issue indefinitely, Wayne Ware 2nd. Motion failed (Chris Dyer abstained). George Meyer motioned that WCHC should reimburse the Williamson Museum for expenses incurred for meeting notices, etc. Ed Lansford 2nd. There was no discussion. Motion passed by unanimous hand vote. (Chris Dyer abstained).

Marker Report – Ed Lansford has finished photo copying old clippings in historical files for preservation and continues his work on organizing the WCHC files.

Chris Dyer announced that February 5 is the opening date for the “Fighting Back” exhibit at the Williamson Museum and invited the WCHC membership to attend.

Wayne Ware – Asked members to visit the cemetery page on our website which includes a video and write up of the Hopewell Cemetery work.
